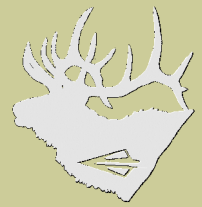

## Board Meeting

The Annual meeting of the Cheyenne Field Archers was called to order at 5.48 pm on January 8<sup>th</sup>, 2011 at the Cheyenne Field Archers Office.

## Approval of Minutes & Treasurer's Report

Mary Tharp did not present the Minutes from the December Board Meeting.

Mary Jo Day presented the Treasurer's Report from December. Patrick Miller made a motion to accept the December Treasurer's report and Jim Seekins seconded the motion.

**Membership Report** was given by Mel Schlagel. He reported that 55 to 60 members have renewed their membership. The door lock will be changed January 31<sup>st</sup>. He also reported that CFA has 275 members registered. The last half of the year had approximately 30 new members join.

**Years Accomplishments**-the range floor was painted and should last at least two years before it will need to be done again. We got the new trailer to help with the remote shoots.

**Club Shirts, hats and decals**-we still have club shirts which cost \$18.00, t-shirts from BHW for sale for \$10.00 (There are 2XL, Mediums and Small long sleeves available and some short sleeved ones available), hats which cost \$20.00 (there is no profit on the hats) and CFA window decals for your vehicles for \$5.00. It was discussed that we bring the shirts, hats and decals out on league nights for members to purchase.

**Thanks**-Bob Day extended his thanks to the officers, board members and to all the CFA members for a great year.

## New Business

**Proposed Budget**-Bob Day reported that as everyone looks at the proposed budget that they may notice that the budget is not balanced. The two proposed changes included extra money to redo the outdoor range so it doesn't look like our trash pile as people drive up and targets for the Curt Gowdy

range. He said he realizes that the club will not be able to do this every year without raising fees, either membership or some of our larger shoot fees to cover the shortfall. Bob Graham brought up that we should still work on donations, for instance Bow Hunters Weekend could make \$4,000 in donations. A motion was made by Bob Graham to accept the proposed budget and was seconded by Jim Seekins. A vote was taken and there were none opposed. The 2011 budget was adopted.

**Club ByLaws**-changes were advertised for two months, November and December 2010.

**Article I**-change was giving the board authority to appoint a successor when there is no alternate available to fill a vacancy in the board until it can be voted on at the next annual meeting, except for the President position. A vote was taken and it passed by unanimous vote.

**Article II**-change adding job descriptions for the board members. A vote was taken and there were none opposed. The change passed.

**Article IV**-the change was clarifying that the club would pay NFAA fees for board members up to five total including the officers, to maintain our NFAA accreditation only if there are not five NFAA members in our general membership. A vote was taken and there were none opposed, the change passed.

**Article V**- was changed that any member of the board of Directors who misses three meetings without substantial reason will be replaced by one of the alternates. A vote was taken, there were none opposed, the change passed.

**Article VI**-the change was that there



Is only one signature required on all checks. A vote was taken, there were none opposed. The change passed.

**Article VII**-the change was that the board could purchase a single item costing less than \$1500.00 without being voted on by the general membership. A vote was taken, there were 21 yes(s) and 15 no(s). The change passed.

**Article IX**-which was only a verbiage change from initiation to building fee. A vote was taken, there was only 1 opposed, the change passed.

**Article XI**-which spells out the individual and family membership fees which didn't change this year, and for new members starting after January, the fee will be prorated. A vote was taken, only 2 opposed, the change passed.

**Article XII**-the change only spelled out the associate fees. A vote was taken, none opposed, the change passed.

**Article XIII**-the change only spelled out the single youth membership fee. A vote was taken, none opposed, the change passed.

**Article XVI**- the change was that future by-laws be posted in the Newsletter in November and December. A vote was taken, none opposed, the change passed.

**Article XVIII**-prohibiting broadheads on the indoor range. Discussion surrounding this ensued. A vote was taken and the majority was opposed to adding this article. The addition of this article did not pass.

**Archer of the Year Award**-was awarded to Al Tharp for his work for the club.

**Election of Officers**-Robert Day, President; Bob Graham, Vice President; Mary Jo Day, Treasurer; Mary Tharp, Secretary; Board Members-Al Tharp, Matt Rusk, Mike Lancaster and Craig Deuel; alternate board members-Jim Fraundenlist, Dan Conrad and Tim Whetsell. A motion was made by Patrick Miller to accept the

nominations of the officers, board members and alternates, it was seconded by Craig Deuel.

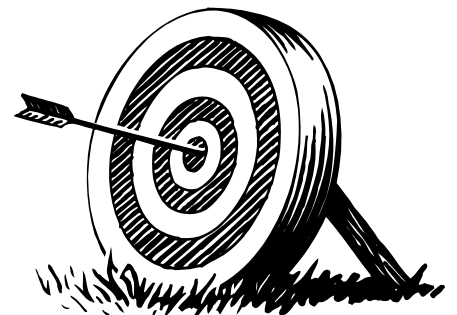
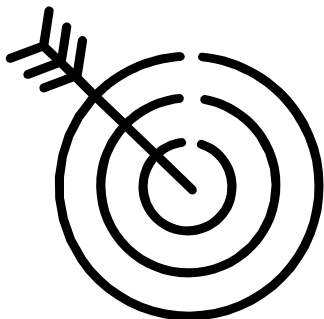
