Minutes of the Annual Meeting

January 9th, 2021

Meeting was called to order at 3:07am by Board President, Neal Perkins.

Minutes from the December meeting were reviewed and discussed. One change needs to be made - # of members reported as 366, actual # of members reported was 266. Motion was made by Greg Wooden to accept the minutes with one correction, second by Jim Mallon.

December Treasurer's Report and the December P & L was presented by Board Treasurer, Monica Mallon. Both were reviewed and discussed. Motion to approve was made by Greg Wooden, second by Judy Wooden.

A budget item from last year was refinishing the floor. This has been partially completed.

OPEN DISCUSSION:

Scholarship Committee Report

Lora reported that even though they didn't get to hold their dinner event, the committee was still able to give away scholarships. The final was 5 scholarships for a total of \$4,500.00. Ticket holders were contacted about refunds on ticket costs, but most donated the money back. Safari tickets are still for sale, we will draw a winner at the 3rd leg of the Triple Crown. The Outfitter has extended the safari dates to 2022 or 2023 due to COVID travel restrictions. The Scholarship committee is hoping to host a dinner in April but will be determined by COVID restrictions. They will not solicit donations from businesses this year, will utilize last year's donations. The scholarship application is on the CFA website as well as the CFA Facebook page. Applications are due by April 1st.

JOAD Report

Kent reported that they had a delayed start this year due to COVID restrictions. A survey was sent out and they will have a delayed start of January 23rd. Approximately 40 kids responded that they would participate. It will run until mid-May. Kent also gave a big thank you to the club for use of the building and time to hold the program.
