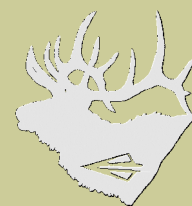

Board Meeting

Approval of Minutes & Treasurer's Report

The Board meeting of the Cheyenne Field Archers was called to order at 7:00 pm on March 7th, 2011 at the Cheyenne Field Archers Office.

The secretary's report was read. Bob Graham made a motion to accept the secretary's report as read, Tim Whetsell seconded the motion.

Mary Jo Day presented the Treasurer's Report. Bob Graham made a motion to accept the Treasurer's report and Al Tharp seconded the motion. Jim Frauendienst questions the CDs vs Money Market Certificates. Mary Jo and Bob will con-

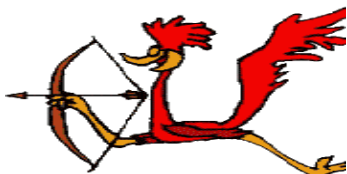

Membership Report was given by Bob Day. He said Mel Schlagel reported that 175 people has signed up. He said there are 4 to 5 people signing up per week, out of that 2 to 3 are new members.

Old Business

Triple Crown: the feedback from the changes in the lines especially the cubs has only been excellent.

Mini Classes-Neal Perkins held the class and has had positive feedback. He will hold another one on March 23rd, the Wednesday before Triple Crown, it will be peep sights and D-loops.

Range Lighting-Jim Frauendenlist said that Mike Hoover said he knew about the lights that are in the building, but they are yellow. Al said he talked to the owner down at Rocky Mountain Archery and the owner down there said he is calling his electrician back in to fix the lights, that the field is too dark and he's changing it. He also said that the soffet probably would have to be painted when they do that. Al made a motion that we should see what happens after the owner of Rocky Mountain Archery changes it. He subsequently withdrew the motion after discussion that LED lights might make a difference. Bob Graham made a motion to investigate the different lights (yellow vs led lights vs blue halogen) and make a recommendation at the next meeting. Craig Deuel seconded it.

Third Leg of Triple Crown- the same people will volunteer however the menu will be changed.

Office Wall Extension-It has been discussed before and motions were made to enclose this area, but it hasn't happened. Because of the liability issue with kids climbing up on top of the office and adults using it as a tree stand, Bob said we need to do something about it. Jim Fraundenlist said that he got an estimate on the materials of \$409.00 and Leaning Tree Construction will donate ½ day labor to work on it. Bob Graham said they should check with Truss Craft for 2X4s. Al Tharp made a motion to enclose area above the office, seconded by Bob Graham. Al and Jim start on Monday.

New Business

B.O.W. Donation-Al Tharp made a motion to make a donation to B.O.W., seconded by Bob Graham.

Triple Crown Grand Prizes were discussed. It was decided that we shop around and see what we can get that will work into our budget.

3d Inventory-is set for April 2nd at 8:00 am to prepare for BHW.

Spring Cleanup Work Party-is set for April 9th at 8:00 am. This will only be indoor stuff.

Re-entering tournaments rules-3d-you can only re-enter if you re-shoot for fun or hunter class. Discussion on changing the rules to be consistent and it was decided to keep the 3D and Paper Target tournament rules separate. There is no advantage on the paper targets if you reshoot in a different class. Therefore, a motion was made by Matt Rusk to allow shooters on paper targets ONLY to re-enter a tournament and shoot two different classes if they want, it was seconded by Bob Graham.

Access Yes-Discussion on whether CFA wanted to sponsor two shoots to benefit Access Yes as we have in the past. It was decided to go ahead and use the proceeds from the Tuesday night 3D shoot, April 19th and Thursday night 3D shoot, April 21st, 7:00 pm. The club will need donations for door prizes.

NASP-will be contacting the club to see if members want to shoot at their shoot to help raise money for the students to go to National. It was April 22nd at McCormick last year and had 10 meter shots and 15 meter shots. We will keep you informed when this benefit shoot will be.

Grant for Curt Gowdy Outdoor Range-Neal Perkins and Mike Hoover are working on the Grant for Curt Gowdy outdoor range, and they will piggy back bales for our outdoor range on that bid to get them for a little less.

Shootoffs and Payouts for Triple Crown-There was discussion about the Triple Crown shoot-offs when there are ties for the top positions. Because some cannot return for shoot-offs during the separate legs, it was discussed that rather than do a shootoff, that the top shooters split the payouts for the top positions for each leg. But then for the overall Grand Prizes, that it be mandatory for archers to come back to shoot-off if there is a tie or else they would be disqualified.

Adjournment-Bob Graham motioned that the meeting be adjourned, Mary Jo Day seconded it. The meeting was adjourned at 8:33 pm.

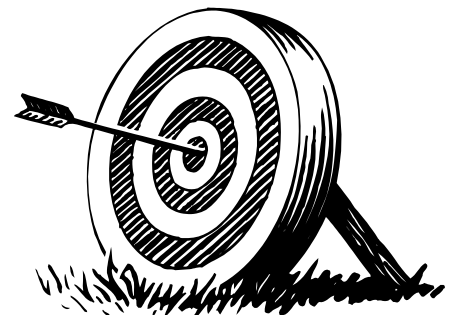
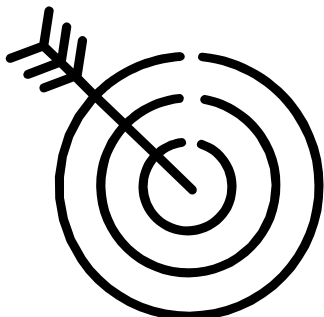

Other Business

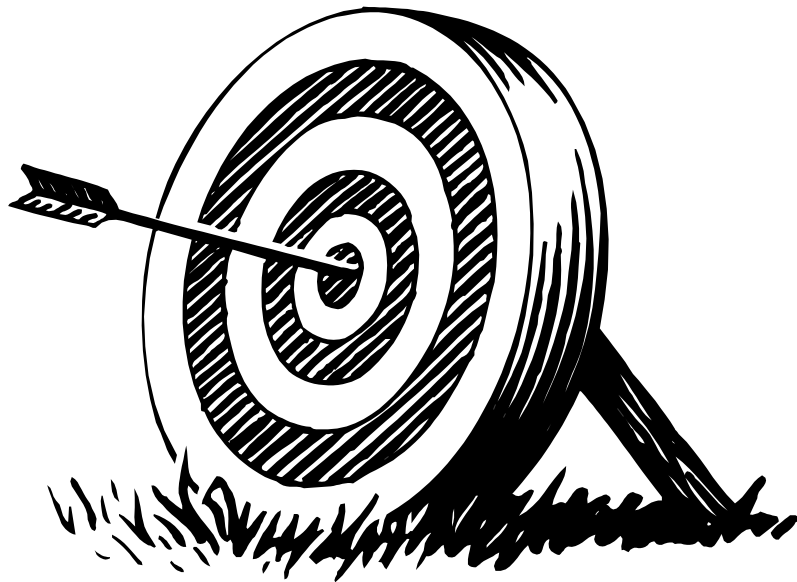
