## Other Business (contd)

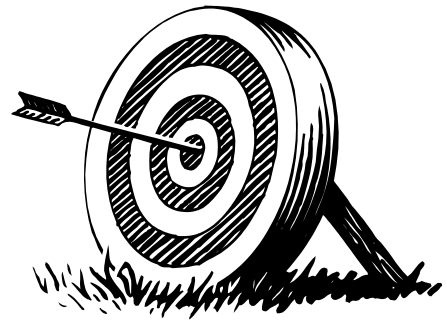
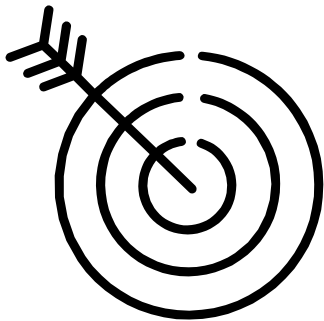

## Miscellaneous

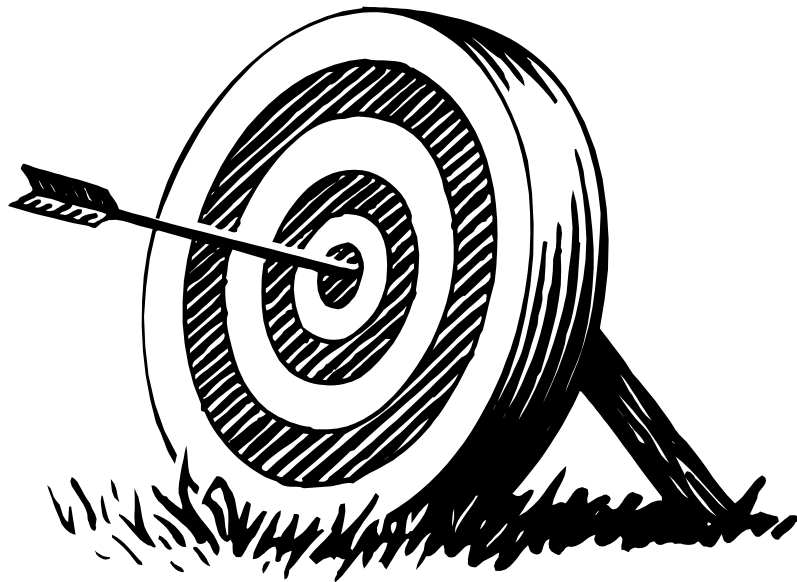
Attached are the changes being proposed for the Cheyenne Field Archers Bylaws. They have to be advertised for two months before being voted on at the annual meeting in January 2011.
