Minutes from November 11, 2019

Attendance: Chris Moody, Greg Wooden, Kelly Thornberry, Mike Lancaster, Dan Conrad, Gary Cox, Kent Ketterling, Cleata Zelenka, Neal Perkins, Jim Mallon, Charlie Hersch, Mary Tharp, Al Tharp, Mat Rusk, Christopher Yaney, Mark Moore.

Meeting called to order at 7:04 pm by Vice-President Chris Moody.

- We have 243 current members.
- Minutes from the October 14th board meeting were summarized by Gary. Motion made to accept minutes by Mary; Cleata seconded. None opposed.
- Cleata handed out copies of Profit & Loss YTD comparisons for Oct. and for Jan-Oct. Also, a Balance Sheet as of Oct. 31<sup>st</sup>. There was a discussion on income, expenditures, recently a new computer, upcoming property taxes, trailer licenses and utilities, and money in various accounts. Several people suggested items in budget not completed should be rolled into next year's budget. Mary said Julie Woods will once again be the club's accountant. Also, Mary wants the Bylaws changed requiring an audit to be done in Dec. so the results can be presented at the annual meeting and an audit whenever the treasurer changes. Mary made a motion to accept Cleata's treasurer report.
- A question was raised why the CFA Scholarship Foundation is completely separate from CFA, even though they use the facilities and share the name. Greg said this was necessary for it to get 501c(3) status and donations to be tax deductible, and have their own separate financial accounts.
- Under old business, there was a discussion about raising the annual membership fee. Fund-raisers have consistently brought in more money than the proposed fee increase would. It was decided to table the fee increase until possibly next year. Neal made motion;
- There was a discussion about buying neighboring land and/or increasing the building's size, but the amount of extra money derived won't justify the cost.
- Dan said he has gotten approval from the new Curt Gowdy supervisor for the RMAA shoot in May and BHW. The supervisor asked that the paperwork be submitted by year's end. Several C.G. range bales next to be replaced.
- Greg and Mary got bids on a new DVR and indoor/outdoor cameras. Greg said he would hardwire the system in, including 6 cameras for from \$1300-\$1400, much less than the bid received by Mary (\$4500). Greg also said he could get a backup hard drive (2 TBs) for the new computer for about \$50.
- Mary read through the proposed Bylaw changes in the Articles, Recognition of Duties, Financial Considerations, and Audit And Inventory. Minor word changes were suggested. The proposed Bylaws will be available on the club's website and Facebook page. **Also, see proposed changes on Page 3.**
- Neal led a discussion on the arrangements for the Access Yes and Trad shoots in Dec. There is money budgeted for advertising. He also proposed handing out tickets to people who attend the leagues. Each month a ticket will be picked at the board meeting and the winner given a \$25 gift card.
- Motion to adjourn at 9:04 PM by Mary, seconded by Al.

## Article IV

### RECOGNITION OF DUTIES

For recognition of their duties, all Board members and officers shall receive a Cheyenne Field Archers shirt. The four officers and 1 Board member shall also have their NFAA paid by the Cheyenne Field Archers **if needed**. There must be five (5) NFAA members to maintain NFAA accreditation (**No NFAA memberships will be paid by the Club for members other than the officers and 1 board member**).

## Article VI

### FINANCIAL CONSIDERATIONS

The membership shall vote on the annual budget during the annual meeting. All budget items may be paid without the approval of the members or the Board of Directors as to each individual item. All checks will be signed by either the President, Vice President, the Treasurer or Secretary. Only one signature will be required. There shall be ~~six~~ **five** separate bank accounts: checking, CD 1 & CD 2 funds, ~~Scholarship Fund~~, Savings II and building fund. **There will be no future movement of funds from Cheyenne Field Archers, Inc. without being presented and voted upon by the general membership. This includes changing banks, adding new accounts or closing accounts, etc.**

## Article VIII

### AUDIT AND INVENTORY

There shall be a **mandatory yearly transactional audit performed with a report either by an accountant or by a club committee of no less than 3 club members in good standing in December of each year prior to Annual Meeting and at any point that the Treasurer steps down.** and An inventory audit may be conducted in order to determine the financial status of the Club, if requested by any member in good standing.

## Article XVIII

### LIABILITY INSURANCE CERTIFICATES

All Organizations not affiliated with Cheyenne Field Archers, Inc. wanting to use the building for non-CFA affiliated events, must submit a request for use of facility and receive approval by Cheyenne Field Archers, Inc. board prior to use. Five (5) days prior to use the organization must sign a release disclaimer and present a Certificate of Liability Insurance reflecting Cheyenne Field Archers, Inc. as additional insured with the amount of \$1,000,000 \$2,000,000 aggregate coverage.
